


# NEWS FROM THE PARK SHORE ASSOCIATION

#### **2024 Beach Passes & Directory Now Available**

# **Park Shore Association Annual Meeting to Go Virtual**

In a continuing effort to reduce expenses and rebuild the needed storm reserves for our beach park, the Board of Directors has decided to cancel our in-person Annual Membership Meeting on Wednesday, February 7th and will instead provide a "virtual" presentation much like last year.

The official purpose of the meeting is to elect new members to the Park Shore Association Board of Directors and transact any other business to come before the meeting. There are three existing board members nominated for re-election – Stan Karpf, Michelle McLeod and Ellen Seigel - and two nominees as new appointments to the Board – Jere R. Kiesel and Ed Monroe.

Members also will be asked to vote on amending the Bylaws of the Park Shore Association, Inc. The Bylaws have remained unchanged since the creation of the Association more than 50 years ago. A committee was appointed by the Park Shore Association Board of Directors to review the original Bylaws and propose any necessary changes to eliminate outdated or obsolete provisions, clarify ambiguous provisions, and make them more reflective of current laws.

#### **Did You Know?**

Many of you likely travel on this road each and every day, whether to run errands or to get to work. But did you know Park Shore Drive ranks as one of the busiest streets in the entire city?

According to the City of Naples Streets and Stormwater Department, the two-way volume on Park Shore Drive in March 2023 reached 15,104 vehicles per day. Since there are only 1,440 minutes in a day, that averages to just over 10 cars per minute heading either east or west.

The latest counts reflect the overall growth of Park Shore in both residents and service vehicles. They also reflect the seasonality of Park Shore. In June 2023 and September 2023, traffic volumes on Park Shore Drive were nearly half the March 2023 totals with 7,624 and 7,627 vehicles per day, respectively.

Keeping safe requires everyone's participation. The Naples Police Department reminds drivers to strictly abide by all traffic enforcement signs, especially the stop lights and stop signs on Park Shore Drive. It should also be noted that the wide bicycle lanes on both sides of the street are NOT turn lanes and should not be used for overnight parking or long-term construction vehicles.

#### **Anyone Up for a Good Game of Chess?**

Park Shore resident Michael Palmer writes that he and his wife have enjoyed the beach park as winter residents from the United Kingdom for nearly 10 years and have often envisioned how wonderful it

could be to play chess there in the open air, particularly on the existing inlaid table.
